Established in 2017 in memory of Ann Victoria Phillips. Ann was from Richmond, Kentucky, formerly of Burnwell, Kentucky and a graduate of Belfry High School. She had been a teacher in the Richmond school system.

Criteria

1. Restricted to students who attend classes on the Williamson Campus of Southern West Virginia Community and Technical College.
2. Students who apply for the scholarship must express an interest in pursuing a baccalaureate degree at a four-year institution.
3. The scholarship award will be based on financial need and/or academic performance.
4. Students must complete FAFSA (Free Application for Federal Student Aid) to be considered for this scholarship.

All scholarships awarded by the Southern Foundation are "last dollar scholarships" designed to provide funds to those students who have an unmet financial need after applying for other sources of assistance. If a student receives a scholarship, it will be counted in determining his/her financial need and may be reduced, if the scholarship, when combined with other sources of assistance, more than meets the student's documented financial need.
