Established in 2006 by native Logan Countian and Huntington resident, Robert Shell, Jr., his wife, Lena, his mother Doris, and other Shell family members. The scholarship is designated for students planning to graduate from Southern West Virginia Community and Technical College with the intentions of continuing their educational goals at Marshall University.

Criteria

1. Applicants must be a graduating senior from Logan High School.
2. Must have a minimum GPA of 3.0 or higher.
3. The award amount is \$1,000 per academic year and may be used for tuition and/or textbooks.
4. Students must complete FAFSA (Free Application for Federal Student Aid) to be considered for this scholarship.

All scholarships awarded by the Southern Foundation are “last dollar scholarships” designed to provide funds to those students who have an unmet financial need after applying for other sources of assistance. If a student receives a scholarship, it will be counted in determining his/her financial need and may be reduced, if the scholarship, when combined with other sources of assistance, more than meets the student’s documented financial need.
