- 1. MUST BE A NON-TRADITIONAL STUDENT (AGE 22 OR OLDER).
- 2. RENEWAL APPLICANTS MUST MAINTAIN A CUMULATIVE COLLEGE GRADE POINT AVERAGE OF 3.0.
- 3. ALL APPLICANTS MUST BE A MINGO COUNTY RESIDENT.
- 4. Must be high school graduate or have GED with a minimum score of 40.
