EMERGENCY FINANCIAL AID TO STUDENTS AS OF SEPTEMBER 30, 2021

July 1, 2021 - September 30, 2021 Quarterly Report

- 1. January 17, 2021 Southern West Virginia Community and Technical College (Southern) received a total allocation of \$2,843,370 in HEERF II Coronavirus Response and Relief Supplemental Appropriations (CRRSAA) funding pursuant to the Institution's Certification and Agreement for Emergency Financial Aid Grants to Students.
- 2. As required, Southern will distribute (\$761,609) in student portion of HEERF II (CRRSAA) emergency grants to students. Thus, satisfying the requirement that the Institution spend the same dollar amount, as they were required to spend under the HEERF I (CARES Act). The Institution has allocated \$660,076 from the Institution portion to make additional emergency financial aid grants available to students. The Institution has allocated an additional \$527,242 from the Institution portion to make additional emergency financial aid grants available to students. A significant portion of the total allocation has been marked to directly assist students with exceptional need. These grants can be used by students toward educational costs for any component of their cost of attendance and other emergency costs that arise due to coronavirus.

- f) The total number of students at the institution eligible to receive Emergency Financial Aid Grants to students under the HEERF II (CRRSAA) funds was 1077 students (Spring202102), 110 students (Summer 202103), 41 students (Fall 202201), 467 students (Fall 202201), 477 (Fall 202201) for a total of 2172 students.
- g) As of June 2021, Southern West Virginia Community and Technical College had \$600 for 1 student that was undelivered, there have been logistical challenges of delivery; method used for refunds through our third party vendor are no longer valid, closed bank accounts, or change of address without notification.

- 4. Emergency grants were processed on March 3, 2021, a notification was sent to BankMobile who disbursed the funds based on the individual student's choice. Students were permitted to choose to have the funds deposited into a bank account or posted to a prepaid debit card that is valid in all locations that accept Mastercard or Visa.
- 5. Additional Emergency grants were processed on June 16, 2021, a notification was sent to BankMobile who disbursed the funds based on the individual student's choice.
