CARES ACT Higher Education Emergency Relief Fund Reporting

Emergency Financial Aid to Students

As of Friday, July 13, 2020

Statutory Authority: Section 18004 (e) of the Coronavirus Aid, Relief, and Economic Security Act (CARES ACT), Pub. L. No 116-136, 134 Stat. 281 (March 27, 2020) provided \$761,609 to Southern West Virginia Community and Technical College that was restricted for distribution of emergency grants to students for expenses related to the disruption of campus operations due to coronavirus including eligible expenses under a student's cost of attendance such as food, course materials, technology, health care, and child care.

Section 1004(a)(1) requires the following information to be made available in a format and location that is easily accessible to the public within 30 days after the date when the institution received its allocation of funds (May 11, 2020) from the Department of Education. The following information includes all required disclosures:

- 1. Southern West Virginia Community and Technical College signed and returned to the Department of Education, the Certification and Agreement and the assurance that the institution would use, no less than 50% (\$761,609) of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to Students.
- 2. Southern West Virginia Community and Technical College received a total of \$1,523,218 in CARES Act funding pursuant to the Institution's Certification and Agreement for Emergency Financial Aid Grants to Students. As required Southern will distribute 50% (\$761,609)
- 3. As of May 18, 2020, Southern West Virginia Community and Technical College has disbursed a total of \$686,475 in Emergency Financial Aid Grants to eligible students under Section 18004(a)(1) of the CARES Act.
- 4. As of July 13, 2020, Southern West Virginia Community and Technical College made additional disbursement to 113 students totaling \$76,275 in Emergency Financial Aid Grants to eligible students under Section 18004(a)(1) of the CARES Act.
- 5. As of July 13, 2020, Southern West Virginia Community and Technical College has disbursed a total of \$761,609 in the student portion of the CARES Act Funding and \$1,141 has been disbursed to students in the school portion of the CARES Act Funding.
- 6. The total number of students, as of May 18, 2020, at the institution eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is 1,017 students.
- 7. The total number of students, as of July 13, 2020, at the institution eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is **113 students.**

- 8. The total number of students who have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act is **1,130 students**.
- 9. Southern West Virginia Community and Technical College determined that any student who met the eligibility requirements under Section 484 in Title IV of the Higher Education Act of 1965 and who were not enrolled in 100% online programs prior to March 27, 2020 were financially impacted by the disruption of campus operations due to coronavirus. Eligibility for Section 484 of Title IV of the Higher Education Act of 1965 was determined by requiring all students to complete a 2019-2020 FAFSA and by a review of each student's compliance with Standards for Academic Progress (SAP). Students who failed to complete a FAFSA or comply with SAP were deemed to be ineligible to receive an Emergency Financial Aid Grant.
 - 1. Southern officials identified the following campuses provided resources that were lost during the disruption of services caused by the Coronavirus:
 - 1. Under normal operating conditions, Southern provides all students with access to computer labs, printers, photocopiers, and workstations throughout its Logan, Williamson, Boone, Wyoming, and Lincoln locations;
 - 2. Students on Logan and Williamson campuses have access to physical books through our campus library. Boone, Wyoming, and Lincoln campuses have access to physical books through intercampus library book loans;
- Southern provides students who have food security issues access to our on-site student food pantry which was not available during campus closure.
- Nearly all students who are attending campus-based courses utilize the library, computer hardware, WIFI, photocopiers, software, and printers provided at the campuses, When the Coronavirus forced the closing of our campuses, these resources were no longer available to students. Moving to a 100% online format meant that students had no choice but to obtain these resources on their own. Southern believes that this factor alone qualifies any student who meets the eligibility requirements under Section 484 in Title IV of the Higher Education Act of 1965 and who were not previously enrolled in 100% online majors to receive a baseline allocation to cover the cost of acquiring hardware (computers, printers, or other required electronic devices) and to help pay for WIFI access through DSL internet or "hot spot" technology. These students were eligible to receive a base Emergency Financial Aid Award of \$675.
- The remaining funds were disbursed July 13, 2020, to eligible students to cover expenses caused by the disruption of classes that addressed technology issues and food insecurities by the disruption of our campuses. Students were notified about the opportunity in many ways including email and social media
- Before any Emergency Financial Aid Grants were distributed, each student's eligibility was confirmed by the financial aid staff's review of FAFSA and SAP status.
- Southern established a separate refund code to track all CARES' Act Emergency Financial Aid
 Grants to ensure that funds were not diverted to pay any balances due to Southern for unpaid
 tuition or fees. Once the disbursements were processed, a notification was sent to Bank Mobile
 who disbursed the funds based on the individual student's choice. Students were permitted to
 choose to have the funds deposited into a bank account or posted to a prepaid debit card that is
 valid in all locations that accept Mastercard or Visa.
- Communications to Students. Below is an example of the communication that was sent to awarded students. Students who were not in the pool of eligible students were not notified specifically that they did not qualify for funds.

Initial Notification to All Students

April 18, 2020

Dear Student,

The U.S. Department of Education (ED) has announced plans to release Higher Education Emergency Relief Funds (HEERF) to students under the CARES Act for delivery to eligible students.

Southern has not yet received the HEERF funds. Interim President Sam Litteral explained. "Student Financial Aid, the Business Office and Technology Services are all working together to develop a system that will provide students their grant funds as soon as possible. The Department of Education is providing guidelines for eligibility. This grant provides emergency funds to students for their expenses related to the disruption of campus operations due to coronavirus, such as food, housing, course materials, technology, health care, and child-care expenses.

Funds can not be distributed until the final guidelines and eligibility are determined by the Department of Education. Spring 2020 classes were moved online on March 23, 2020, to allow for social distancing during the COVID-19 pandemic. The college will offer all summer 2020 courses online and will waive online course fees.

Southern will continue to use BankMobile Disbursements to deliver all funds to students. If you have already set up your BankMobile account, you are all set to receive your funds. If you have not setup your BankMobile account, please contact the Business Office at BusinessOffice@southernwv.edu to request assistance in getting your BankMobile account setup.

We are working on getting answers as quickly as possible and will be in touch with you to provide more information when it becomes available. Please continue to check your Southern email account for more details on how and when these funds will be disbursed.
