SECTION 1. PURPOSE

1.1 Contributions to the Southern West Virginia Community College Foundation, Inc. will be assessed an administrative fee that is used to support the Foundation's operating expenses, as well as other priority needs to be determined by the College or Foundation. Effective fund-raising requires the deployment of financial resources to cover direct costs of soliciting, processing, and accounting for donated funds.

SECTION 2. DEFINITIONS

- 2.1 Administrative Fees the costs the Foundation incurs to carry out its charitable mission, including expenses for grants administration, general support services, and non-grant charitable activities. Administrative fee revenue is directly related to the Foundation's cost of doing business.
- 2.2 College- Southern West Virginia Community and Technical College.
- 2.3 Foundation Southern West Virginia Community College Foundation, Inc.
- 2.4 Restricted Funds donations that are to be used for specific purposes.
- 2.5 Unrestricted Funds donations that are available to use for any purpose.

SECTION 3. POLICY STATEMENT

3.1 An annual administrative fee of one percent (1%) will be assessed on all investment accounts. This shall remain in effect indefinitely unless changed at the discretion of the Foundation Executive Board. Investment accounts include both restricted and unrestricted funds.

SECTION 4. BACKGROUND OR EXCLUSIONS

SECTION 6. RESPONSIBILITIES AND PROCEDURES

6.1 The funds will be deposited into the General Fund and coded as administrative fees.
